## **Our approach to teaching learners with SEN-D**

At Essendine Primary School we believe in participation for all our pupils and will do our utmost to ensure all children reach their potential. We promote independence for all learners, and we ensure all pupils have respect for others and become lifelong learners equipped for the future by providing an excellent and inspirational education through a welcoming, safe, happy and supportive community. We strive to provide a positive environment, enhancing the learning for all; both children and adults, regardless of ability, race or gender. We aim to work together-parents/carers, staff, governors and children – for the benefit of all those who come to our school, including those with additional needs. We will not tolerate any form of bullying and we have a clear anti-bullying policy in place.

We value high quality teaching for all learners, and actively monitor teaching and learning in the school. We also monitor the progress of all learners and staff continually assess to ensure that learning is taking place and progress made. Our whole school system for monitoring progress includes termly pupil progress meetings as well as termly learning plan reviews for pupils with additional needs.

## **How we identify SEN-D?**

At different times in their school life, a child or young person may have a special educational need. The code of practice defines SEN-D as follows:

**A child or young person has SEN-D if they have a learning difficulty or disability which calls for special education provision to be made for him or her. A child of compulsory school age or a young person has a learning difficulty or disability he or she :**

- **has a significantly greater difficulty in learning than the majority of others the same age or**

- **has a disability which prevents or hinders him or her from making use of facilities of a kind generally provided for others of the same age in mainstream schools or mainstream post-16 institutions**

Where pupils' progress is significantly slower than that of their peers, or fails to match their previous rate of progress, despite high quality teaching targeted at specific areas of difficulty, it may be that a child has SEN-D. Information will be gathered, including seeking the views of parents and the pupil, as well as from teachers and assessments.

There can be many reasons for learners 'falling behind'. These may include absences, attending lots of different schools, difficulties with speaking English, or worries that distract them from learning. This does not mean that all vulnerable learners have SEN-D. Only those with a learning difficulty that requires special educational provision additional to other learners will be identified as having SEN, this can include 'looked after' children.

In 2018-19, our SEN-D profile showed that we had 11% of children identified as having SEN-D with 2.5% having SEN-D statements

The four broad areas of special educational needs that children are now identified with include:

- Cognition and learning (including maths, reading, writing and spelling etc)
- Communication and interaction (including speech and language difficulties and problems with social interaction)
- Physical and sensory (including disabilities such as those affecting mobility, sight and hearing)
- Social, mental and emotional health (from time to time, some pupils require extra pastoral support and we make arrangements for them to share their views and worries, including those with SEN-D)

### **What should you do if you think your child may have special educational needs?**

If you have any concerns regarding your child's progress or well-being, then please speak to your child's class teacher in the first instance who will then if needed, use

the school's referral procedure to involve either the HSL (Home School Liaison team) or Tim Killick (Inclusion Leader) to discuss your concerns.

### **What we do to support learners with SEN-D?**

If a learner is identified as having SEN-D, we will provide support that is 'additional to' or 'different from' the differentiated approaches and learning arrangements normally provided as part of high quality personalised teaching intended to overcome barriers to learning. This support is set out in our whole school provision map.

The following system will be used by our school to track and monitor SEN pupils:

- All children will receive high quality teaching with appropriate differentiation.
- Inadequate progress of individual pupils identified – high quality teaching targeted at areas of weakness.
- Continued inadequate progress from particular pupils – liaise with Inclusion leader to assess whether there is a significant learning difficulty.
- SEN support that is 'additional to' or 'different from' other learners to be put in place using a four-stage process; Assess, plan, do and review.

**Assess** – this involves taking into consideration all the information from discussions with parents or carers, the child, the class teacher and assessments.

**Plan** – this stage identifies the barriers to learning, intended outcomes, and details what additional support will be provided to help to overcome barriers to learning. Strategies will be recorded on a learning plan and will form the basis for termly review meetings, held as part parent/teacher consultations.

**Do** – providing the support – extra assistance for learning or learning resources – as set out in the plan.

**Review** – measuring the impact of support provided, and considering whether changes to that support need to be made. All of those involved – learner, their

parent or carer, teacher and Inclusion Leader –contribute to this review. This stage then informs the next cycle, if necessary.

This additional support, (often called intervention) will be tailored to meet the child’s needs, and will target the area of difficulty. This support may be provided in class or in another area of the school occasionally on a 1:1 basis but more often as part of a small group. The support provided, and its impact, will be monitored closely and shared regularly with the child and with their parents or carers.

For a small number of learners their needs may require access to technology e.g. modified I.T. equipment, recording devices etc.

While the majority of learners with SEN-D will have their needs met in this way, some may require an assessment of needs to determine whether it is necessary for the local authority to make provision in accordance with an Educational Health Care Plan.

Current interventions include:

- Lexia groups (reading intervention)
- Box Clever, A Speech and Language Intervention
- Lego Therapy, a Speech & Language Intervention
- Precision Teaching
- and 1- 1 and small group support with learning support assistants (LSAs)
- Reception Speech and language therapy groups
- Booster Literacy and maths groups
- One O’clock club In The Hub
- ‘Allstars’ Pastoral support through Cricket

## **The Learning Hub**

Essendine has a Learning Hub which is a large space with designated areas. Each has a wide range of equipment and resources for Children who experience social and emotional difficulties in the classroom or playground. The Hub is also used for SLT (Speech and language therapy) and OT (occupational therapy) programmes. The school inclusion team are trained by Tri-borough outreach workers to deliver SLT and OT programmes.

## **What is an Educational Health Care Plan (EHC)?**

An EHC plan ( which replace Statements of SEN) is to make special education provision to meet the special educational needs of the child or young person, to secure improved outcomes for him or her across education, health and social care and as he or she gets older, to prepare for adulthood.

An EHC plan will contain:

- the views and aspirations of you and your child
- a full description if his/her special educational needs and any health and social care needs
- establish outcomes for your child's progress
- specify the provision required and how education, health and social care will work together to meet your child's needs and support the achievement of the agreed outcomes.

You and the school can request that the local authority conduct an assessment of your child's needs. This may lead to an EHC plan. The EHC plan would cover a child from two years to an adult at twenty five years.

## **How we know if this is effective?**

The interventions used will be those that are proven to make a difference for most learners. A baseline assessment will take place at the beginning of an intervention- this will provide the point of reference for measuring progress made by a child, and a target outcome set. These will then be recorded on the child's learning plan. Regular reviews will take place to ensure that the intervention is having the intended effect. Should progress be less than anticipated, consideration will be given to adapting the frequency and/or intensity. These termly learning plan reviews will involve children and their parents/carers as well as class teachers and the Inclusion leader, where a record is kept of agreed actions.

Where difficulties persist, despite high quality interventions and appropriate adjustments, advice and support may be requested from other professionals, with the parents consent. This may involve:

Where a child has an education, health and care plan (EHC), there will be an annual review help in addition to the termly review meetings, taking into account

the views of the child, their parent or carer, and all other professionals involved with the child.

### **Other opportunities for learning**

At Essendine Primary School, we believe all learners are entitled to the same access to extra-curricular activities, and are committed to making adjustments to ensure participation for all. Please contact the School Office if your child has any specific requirements for extra-curricular activities e.g. clubs, play centre

### **Preparing for next steps**

Transition is a part of life for all learners, whether that involves moving to a new class or moving to a new school. We recognise that this 'moving on' can be difficult for all children, but especially so for a child with SEN-D. Consequently, we work closely with parents, children and staff to ensure these transitions run as smoothly as possible.

Planning for transitions within school will take place in the summer term review meetings; transition to secondary school will take place in the summer term of year 5 to ensure adequate time for planning and preparation.

During year 6, information (previously agreed with parents) will be shared with the SENCO at secondary school. This information will outline the needs and support that has proved effective. Where possible, children will visit their new school on several occasions and, in some cases, staff from the new school will visit him/her at Essendine Primary School.
